2023 Results Highlights

We are proud to highlight remarkable results achieved in fostering access to justice for all, particularly for women and marginalized communities in 2023.

Accessibility of Legal Aid Services: More than 10million people were reached.

50,575 Cases were reported to paralegals in which 73% of cases were resolved.



Program Implementation Results 2023



1.1 Protecting women and girls against gender-based violence through Legal Aid.


In the reporting period around 20.8% of all data equal to 10,553 disputes were disputes reported as gender-based violence disputes (GBV), which is lower than the target of dealing with 25% of GBV disputes. This implies declining of GBV disputes in the communities.

Whilst, there are automatic disputes which are in the category of GBV in the table above, legal aid providers have also given a capacity to spot those disputes with GBV elements or concern as per graph below.

About 72% (7,820) of all reported GBV disputes were brought by women,

demonstrating that women and girls are the main victims of GBV. Still girls continued to suffer from Child Marriages, Early Pregnancies and incidents of the Female Genital Mutilation.

Number of Gender based Violence disputes






1.2 Addressing gender inequalities through economic justice projects.

The LSF program is geared to address gender inequalities and systemic limitation to women economic justice and inclusion. LSF supported women to engage in modern agribusiness, Women in mining areas, blue economy, and start-up capitals were given to women.

The chart below shows number of women benefited from various women economic justice projects.





1.3 Increased access, ownership and control over properties to women.

Increasingly women are now directly getting access to and ownership of properties through legal aid services.


In this reporting period the project registered 2,402 inheritance disputes of which 59% of disputes were resolved, with 817 women had access to land, houses, farms, plots and other resources, which in turn have improved their status in the communities.

Women secured 1,793 several types of assets (*in figure below*), with access to land from 1 acre to 20 acres, which is quite valuable to the women, both economically and self-worth.

The highest claimed inheritance land value was from the client in Kibondo district in Kigoma, which was worth TZS 5 million. During the 2023 farming season she harvested 40 sacks of maize using only 6 acres.

This was substantial benefit to her family especially children, which without intervention made by paralegals her community could see a starving family.

Another good example is of Mrs Mariam in Musoma rural, after being assisted by paralegals she recovered her 17 acres of agriculture land from her late husband's siblings, worth TZS 10 million.





The Legal Services Facility (LSF) and Enabel, the Belgian development agency, have officially signed a 10.7 billion grant agreement to implement the Improved Access to Justice for Women through Legal Aid (IMPAWLA) Project.

This collaborative project is funded by European Union (EU) under its flagship initiative called.

"Gender Transformative Action: Breaking the Glass Ceiling."

The project aims to to reduce inequalities in access to justice for women and girls by enhancing their access to quality legal aid services.

Additionally, it will strengthen the organizational capacity of LSF to improve the achievement of its mission. Under this new grant agreement, LSF and Enabel will collaborate to implement a comprehensive legal aid program for women and marginalized groups.

This program will take a holistic approach by focusing on improving the provision of quality legal aid for women, fostering legal empowerment, and promoting a conducive environment for access to justice.

It will leverage LSF's extensive network of paralegals and legal aid providers, enhancing their capacity to deliver crucial services.

A primary focus of this initiative will be on combating gender based violence.

Speaking about the new program the EU Head of Delegation, H.E. Christine Grau, The Resident Representative at Enabel in Tanzania, Koenraad Goekint Said,



Through the Gender Transformative Action Program, 'Breaking the Glass Ceiling', and in particular this initiative, the EU continues to support access to justice for women and girls through legal aid in particular for victims of gender based violence.

The initiative strives to ensure that justice is within reach for all individuals, regardless of their socio-economic status. The period for the implementation on the signed agreement is 26months.

The annual Run for Binti Marathon is set to take place on the 25th May 2024.

The Run aim to mobilize resources and joint efforts to empower girls by ensuring they have access to education and reproductive health rights, including safe menstruation and improved learning environments.

Last year's event benefited students from Nanyamba and Chawi secondary schools in the Nanyamba Town Council by providing them with modern toilets and sanitary pads to girls, helping to maintain their health and ensuring their continuous school attendance.

Speaking during the announcement event, LSF's CEO, Ms. Lulu Ng'wanakilala, stated,

"In implementing our Access to Justice program, it's evident that girls and young women face both avoidable and unavoidable barriers to education, healthcare, and their basic rights.

Announcing this year's race date, Smile for Community's Director General, Flora Njelekela,

"Smile for Community, in partnership with LSF, is thrilled to announce the Third Season of the Run for Binti races, set for May 25 at the Oysterbay Grounds in Dar es Salaam.

The races will include 21 km, 10 km, and 5 km runs, as well as a 55 km bicycle race.

This year's objective is to enhance girls' educational and reproductive health environments.

Funds raised will go towards building and improving sanitation facilities in secondary schools, improving access to clean water by constructing wells, promoting safe menstruation through the distribution of reusable sanitary pads, contributing to environmental conservation through tree planting, and providing education on self-defense and addressing gender-based violence."

The beneficiaries of this year Marathon are more than 10,000 students from five secondary schools in the Lindi and Mtwara regions.

EMPOWERING COMMUNITIES THROUGH MAMA SAMIA LEGAL AID CAMPAIGN.



The campaign was launched by Prime Minister in Dodoma. The LSF LSF is a cochair actively participated in the campaign by supporting paralegals to provide legal aid and education to thousands of people who attend in large gatherings.

At national level the campaign has already been done in Dodoma, Manyara, Ruvuma, Simiyu and Shinyanga regions.

Through this campaign 42 Municipal 452 wards and 1,348 in six regions were reached more than 362,488 has been reached through legal in the implementing regions. 415,280 were reached indluding 7,166 remands in prison

The outcomes of the legal empowerment approach have increased peoples' access to justice both socially and economically by helping to resolve legal problems amicably.

Accordingly, local leaders at the field level have claimed that the work of the partners reduced the workload at their end which otherwise they would have been involved to resolve disputes.

During the monitoring field visits local leaders, policies, courts and government leaders confirmed that the presence of the Access to Justice program helps to decrease petty disputes from their desks that allow them to engage in other developmental agendas.

During this quarter, the LSF issued a call for proposals for Legal Aid providers to offer legal aid services to marginalized communities, with a special focus on women and girls across the country.

The call aims to provide grants to paralegal organizations in every district, both on the mainland and in Zanzibar and enable community access free legal aid services.

This pivotal initiative seeks to eliminate financial barriers, ensuring that individuals in marginalized communities, particularly women and girls, can avail themselves of essential legal assistance.

By offering support to paralegal organizations at the grassroots level, the LSF ensures the availability of legal aid services where they are most needed.

Furthermore, the LSF unveiled the MWANAMKE SALAMA Project, a special initiative to address Gender-Based Violence (GBV) and promote equality for all.

The Mwanamke SALAMA Project will be implemented in five regions, including Shinyanga, Mara, Dodoma, Zanzibar and Kigoma, Through this project, we aim to deliver essential legal aid services to those impacted by GBV, fostering a safer and fairer community for all.



The project seeks to disrupt the cycle of violence and empower victims to seek recourse and protection, promoting gender equality and raising awareness about GBV, the initiative aims to catalyze a shift in societal norms and behaviors, contributing to the creation of a more supportive and inclusive.

With approximately 9600 Non-Governmental Organizations (NGOs) in Tanzania, NaCoNGO plays a crucial role in connecting and empowering these organizations.






LSF's Program team discuss views during the NACONGO meeting.

Empowering Education through sanitation Transformation at Iboja Primary School.









When we have periods, we need washrooms the most," says Mbuke, a student at Iboja Primary School in Ushetu district, Shinyanga region. "In those times, we used to go back home. But when we'd return to school, classes would have started. Because of that, we often missed out on our studies."

Iboja Primary School, located in Ushetu district, Shinyanga region, previously faced a shortage of safe toilets.

Students used traditional toilets, which were not friendly to many, especially girls and students with disabilities. This lack of adequate facilities led to frequent absences from classes, particularly for girls during menstruation periods, as there were no special rooms for them.

Students resorted to using the bushes, leading to the outbreak of diseases due to poor hygiene practices. This situation resulted in regular school dropouts, creating an unhealthy learning environment that threatened the students' health.

Recognizing the challenges faced by children in their school routine, particularly girls who missed classes during menstruation periods, Ramadhan Focus paralegals at PECOIO took action. They mobilized the school committee to address the community through a village assembly.

The idea gained acceptance, and paralegals addressed community members during the assembly, who agreed to contribute 17,500/= to every household. This contribution was paid in two terms, with Tshs. 7,500/= paid initially and Tshs. 10,000/= paid later. The village committee was responsible for collecting all contributions from community members

As a result of the collective efforts of the community members at Iboja Village, they embarked on building 17 toilet rooms. Upon hearing of the community's efforts, government officials at Ushetu District decided to support them. The plan expanded to build 31 toilet rooms, with community members collecting stones, gravels, and sands to commence construction.



Ultimately, they successfully completed the construction of 31 toilet rooms, including two rooms for disabled students and one special room for girls.

The initiative began in 2018, and the completion of the toilets was achieved in 2020. Students began using the new facilities in 2020, and they are now considered the best-designed and topranked toilets among all schools in Ushetu District.

Paralegal mobilization has empowered community members, shifting their focus from government grants to self-reliance.

Legal education initiatives, such as advocating for children's right to education, have united Iboja Village in creating a conducive learning environment.

LSF's "Access to Justice for Women and Children" project has notably contributed to community well-being by providing legal knowledge and resources. Through collaboration and empowerment, LSF has significantly improved the lives of women and children in the community.
